SUMMARY

This is an unclassified position that serves at the pleasure of the Court. This position is responsible for assisting one or two Judges of the Court of Common Pleas with the management of their civil and criminal dockets. All resumes submitted are kept on file in the event of a vacancy with a particular Judge(s).

ESSENTIAL DUTIES AND RESPONSIBILITIES include the following:

- 1. Reviewing and researching legal issues and questions to formulate recommendations on the disposition of motions:
- 2. Assisting in drafting of legal opinions, findings of fact and conclusions of law and various other legal memoranda;
- Responding to questions concerning the docket from attorneys and/or the parties;
- 4. Conducting case management conferences and pre-trials at the request of the assigned Judge(s);
- Performing a variety of other related duties as required.

- Ability to effectively manage a large case docket and produce work product of exceptional quality;
- Ability to analyze legal questions from different areas of the law and to formulate and present recommendations to the assigned Judge(s);
- 7. Strong negotiation skills in order to conduct case management conferences and pre-trials and work with attorneys and civil parties to negotiate settlements and resolve legal issues;
- 8. Ability to complete assigned work without specific direction or instruction regarding manner of completion;
- Ability to work independently without daily supervision and organize and prioritize duties;
- 10. Ability to work effectively and in a professional manner when under stress and confronted with tight deadlines;
- 11. Familiarity with Court operations;
